**APPROVAL OF AGENDA:**

Motion made by Magistrate Dye and seconded by Magistrate Jeffries to approve the agenda. Motion carried unanimously.

**COMMUNITY BUSINESS:**

**2<sup>nd</sup> Reading and Public Hearing of Ordinance 26-920-1 – Data Center Regulations**

Director of Planning and Development Services, Ryan Fischer, provided the 2<sup>nd</sup> reading of proposed Ordinance KOC 26-920-1 regarding Data Center Regulations. **Exhibit #4 1/6/2026.**

Prior to the public hearing portion, County Attorney Berry Baxter addressed the court and the public to provide legal guidance regarding the submitted proposals from Magistrates involving material changes which would require another first reading. Mr. Baxter provided his legal opinion, stating he would recommend the court deny the ordinance, send it back to the Planning Commission with the proposed changes to go through the process again. Mr. Baxter further provided other options; to approve what the Planning Commission has recommended or to take no action which means it would take effect as a matter of law.

The following individuals spoke during the public hearing portion:

Bob Popeck of 1321 Judge Carden Blvd – states he supports the county and technology and encourages communication.

Nathan Oberg of 1414 Yager Lane – believes large data centers are heavy industry, requests the court votes no.

Barry Laws – requests to disallow data centers in IPD, asks the court to vote no.

Arthur Blake – wants it done right, requesting the court votes no.

Stewart Robinson – expressed concerns with hyperscale specifically, power versus energy clarification, believes hyperscale is heavy industry.

Elaine Tischendorf – expressed concerns of size and ecology, requests the court votes no, recommends bringing in people who know how to protect ecology.

Amanda Dreckman - wants to protect human and wild/domestic animals, requests setbacks of at least 1500 feet, requests the court votes no.

Dana Rich – believe nefarious things have been happening for this to just come to light, believes IPD is inappropriate zoning, requesting the court votes no.

Robert Hellin – believes there is a frequency issue

Karen Grant – believes there is no one in Oldham County that fits for a data center, requests the court votes no.

Elizabeth Englert – She is losing hope in elected officials, data centers won't improve electric bills, people's health or the environment.

Amy Welborn – disappointed regarding news from Berry Baxter, requests IPD be removed, requests specific motions and requests the regulations be sent back to the Planning Commission.

Judge Voegelé closed the public hearing portion.

Judge Voegelé addressed the public and the court, sharing information about a data center in Simpsonville. Judge Voegelé stated he does not believe there is room in Oldham County for a hyperscale data center. He is supportive of the data center regulations going back to Planning Commission for further discussion.

Motion made by Magistrate Hawkins and seconded by Magistrate Woosley to deny ordinance KOC 26-920-1 as presented for the purpose of sending changes that members of this body wish to see as part of this ordinance, back to the Oldham County Planning Commission for reconsideration; and also due to those changes being material significant enough, in nature, that the proposed ordinance would require another first reading.

Discussion followed.

Magistrate Logsdon called for the question, Magistrate Woosley seconded. Roll call vote passed 9-1 to stop discussion.

Judge Voegelé asked the magistrates to submit, to his office, a typed document, redlining all suggested changes.

Motion made by Magistrate Haunz and seconded by Judge Voegelé to take a 5-minute break at 4:04pm.

Motion made by magistrate Haunz and seconded by Magistrate Jeffries to return to regular session at 4:16pm.

Magistrate Theiss also shared his experience of touring the new courthouse.


Magistrate Likins congratulated the Indiana Hoosiers and shared the public survey for Stewart Park.
