LGEA & CREA Public Hearing

Judge Voegele presented for the LGEA & CREA Public Hearing. The LGEA (Mineral Severance Tax) amount is \$196,500 and the County Road Aid Fund is \$627,000. The Mineral Severance Tax is used towards the match of various transportation improvements projects; and the County Road Aid is used towards the general repair and upkeep of the county roads (paving and snow removal).

Magistrate Haunz reminded everyone to sign up for Smart911 notifications.


Magistrate Likins wished to thank everyone who is currently running for an office within Oldham County and wished them good luck.
