The Oldham County Fiscal Court convened at 2:03pm, for a Special Called meeting, with Judge-Executive David Voegelé, County Attorney Berry Baxter, and the following magistrates in attendance: Brent Likins, Wayne Theiss, Kevin Woosley, Kevin Jeffries, Chris Haunz, Bob Dye and Michael Logsdon. Magistrate Hawkins was absent.

**APPROVAL OF AGENDA:**

Motion made by Magistrate Haunz and seconded by Magistrate Jeffries to approve the agenda. Magistrate Jeffries requests for items B and D to be removed, as new information has come up and they are further investigating. Motion carried unanimously.

**APPROVAL OF MINUTES:**
