Magistrate Logsdon shared an update on the Rollington Road project. Also wanted to share his commitment to Organ Creek Farms to creating a committee to start moving forward with gravel road standards.

Magistrate Dye shared that school has now started and encouraged the public to be safe around school buses.

Magistrate Hawkins echoed Magistrate Dye's comments about being careful around school buses. Also provided an update regarding the paving and re-striping on Hwy 393.

Magistrate Haunz shared information about the recent heavy rainfall and flooding. Asked the public to send him data/pictures regarding the recent flooding for a project currently being completed. Also reminded the public to "turn around, don't drown" on water covered roadways.

Magistrate Jeffries also commented on the paving and re-striping on Hwy 393. Shared KYTC has now started on 53, from 146 to 42 and reminded drivers to watch for road crews.

Magistrate Woosley shared the upcoming Sprint Triathlon at Wendall Moore Park this coming weekend. Due to this event, there will be road closures from 7am until 12pm.

Magistrate Theiss had nothing to share.

Magistrate Likins spoke again regarding the Organ Creek Subdivision roads and getting them up to a standard that can be managed by the county road department; "where there's a will, there's a way."

Judge Voegele shared another successful Ironman competition that partially took place in Oldham County. Thanked the police, sheriff's office, dispatch and EMS for their assistance during the event. Also shared the passing of County Clerk Amy Alvey's father, Junie Roberts.
