### **Statement of need for project**

South Oldham Little League (SOLL) is planning to serve over 600 children in our spring and over 500 children in our fall 2026 seasons. We have six fields at the facility used by SOLL. These fields each year are in need of standard annual maintenance including grading, aeration and ensuring appropriate drainage. There are also needs in our park related to fences that surround each of the fields. The work of keeping the fields in great shape to play is done throughout most of the year. In 2025, SOLL was grateful to receive a grant that allowed us to upgrade two of our six fields with new dirt, new sod, and appropriate grading of those fields. This helped ensure appropriate drainage in these fields as well as removing rocks that had built up in the dirt over time. We would use any funds from this grant to this year assist in the maintenance needs of the other four fields.

The cost of the field upgrades could range from several hundred dollars to several thousand dollars depending on what work is completed. Any funds received from this grant would be used for the most immediate upgrades needed at the fields as determined by the SOLL Board to ensure they are in best playing condition for those playing in the league.

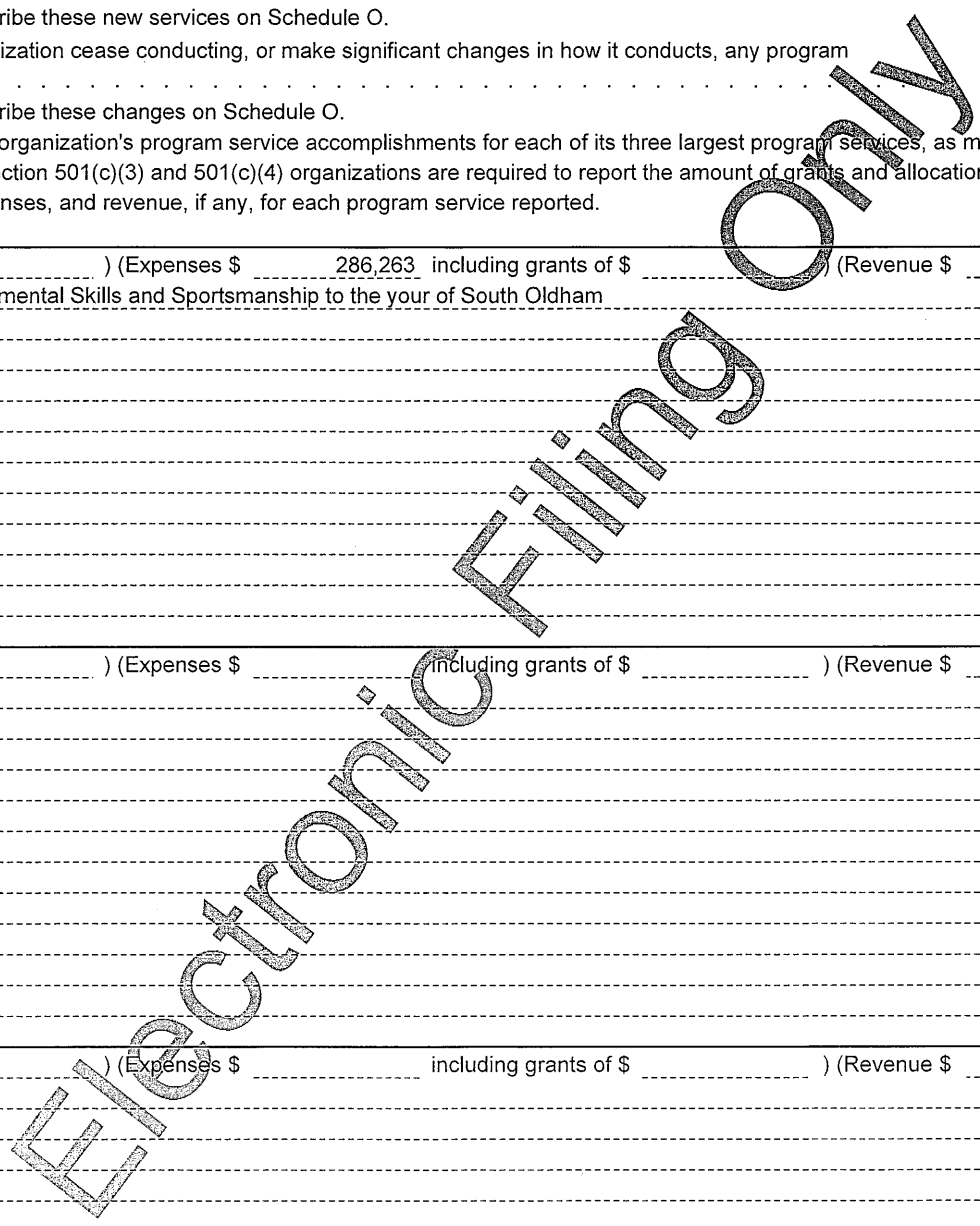
