

NEW FEES WILL APPLY FROM 1 MARCH

As you may have heard, due to significant Federal cuts to Medicare rebates, many General Practices across the country are facing the challenge of remaining financially viable whilst providing quality medical care. For many years, even before the Government froze your Medicare rebate from 2013-2018, General Practices have absorbed the rising costs of healthcare. In 2022, the government increased patients' Medicare rebates by only 1.6%, despite rising costs of medical supplies, medical insurances, accreditation, and costs of staff and rent. Many General Practices have continued to bulk-bill many patients, absorbing the difference, and slowly watching the Profession erode under strain.

Subsequently, from **1st March 2023**, we will no longer be bulk-billing patients with a Health Care or Pension Card. There will be reduced rates for Health Care & Pension Card holders.

Bulkbilling will only apply for children under the age of 16 or Department Of Veterans Affairs patients

For patients who suffer from Chronic Disease please discuss fees with your GP or the Practice Manager as you may be eligible to be Bulk Billed.



Fee Schedule 1 March 2023
