
GETTING THE MOST OUT OF THIS CATALOG

USING THIS GUIDE

From in-depth disaster preparedness courses to targeted training in recovery, volunteer coordination, and rebuilding efforts, the offerings in this catalog are designed to cultivate a culture of readiness and enhance community resilience in the face of disasters. Trainings and Community of Practice events are organized by month for easy navigation. To help users quickly identify content, icons and color scales are used throughout. Course Difficulty

Lutheran Disaster Response courses are free and open to everyone, and we warmly invite all who are interested to participate. While many trainings are tailored for those new to disaster response and recovery, others are structured to be taken in sequence, allowing learners to progressively build their skills. As participants move through each course, knowledge is reinforced and expanded. To help guide learners, a color-coded system is used to indicate the recommended experience level or difficulty of each course:



Suggested Prerequisites

Lutheran Disaster Response may recommend certain prerequisites before attending specific courses. Most of these suggested prerequisites are available through LDR's online training platform and can be completed at the learner's convenience. While not mandatory, these recommendations are intended to provide foundational knowledge that will help participants succeed in more advanced training. Due to time limitations, some courses may not cover these foundational topics during the session itself. Prerequisites are indicated as follows:

From June through November, more than 20 unique trainings, workshops, and networking events are available. Here's how to identify and differentiate each opportunity:



Online Community Conversation

Opportunities highlighted in light blue with a telephone icon represent informal, 60-minute Community of Practice (CoP) online discussions, accessible via video or phone. These sessions foster connection, knowledge-sharing, and collaboration among CoP members. While typically organized by region, all conversations are open to anyone interested in participating.



In-Person Training or Gathering

Opportunities shown in dark blue with a people icon represent in-person events or gatherings. Details about the hosting location are listed beneath each course title. These events may take place over a single day or span multiple days.



Online Facilitated Training

Opportunities marked in green with a globe icon indicate facilitated online trainings hosted via Zoom. These interactive sessions promote active participation through live discussions, polls, breakout groups, and other collaborative activities.



Partner Spotlight

Opportunities highlighted in orange with a spotlight icon represent *Partner Spotlight* sessions. In these events, LDR partners from around the world share innovative and impactful work happening in their communities.

JUST IN TIME TRAINING

JUST IN TIME



A disaster has struck your community—what happens next? Recognizing the urgent and unpredictable nature of such events, Lutheran Disaster Response emphasizes the importance of quickly mobilizing skilled responders. Just in Time (JIT) Training delivers essential information exactly when it's needed most, empowering communities to act swiftly and effectively. Lutheran Disaster Response offers a range of JIT training opportunities designed to meet immediate needs and support rapid recovery.

Online, In-Person and Hybrid Training

Lutheran Disaster Response (LDR) offers a variety of free, self-paced online courses—each averaging about 60 minutes—covering topics such as disaster response basics, case management, construction management, and psychological first aid. A full list is available in this document or on LDR's online learning platform, CollaborNation.

LDR also facilitates in-person training for Long-Term Recovery Groups, Disaster Case Managers, and Volunteer Managers. We collaborate with communities to identify training needs, schedule sessions, and provide experienced facilitators. Trainings range from half-day to multi-day formats. To ensure effective use of resources, we generally require a minimum of 10 participants for in-person sessions, but virtual options are available for smaller groups.

On-Going Mentorship and Collaboration

Lutheran Disaster Response also offers ongoing mentorship and collaboration for Synods, congregations, and Social Ministry Organizations involved in disaster response. We connect your team with experienced members of the LDR Community of Practice for phone or video consultations, providing guidance and support as you navigate specific challenges in your work.

SELF-PACED ONLINE TRAINING

ONLINE TRAINING

Lutheran Disaster Response's online learning platform, CollaborNation, offers foundational courses that participants can complete anytime, from any device—computer, tablet, or phone. Most courses take about an hour and cover a wide range of topics, from preparedness to long-term recovery, tailored to various skill and experience levels.

Disaster Case Management Part 1: Introduction to Disaster Case Management Average of 60 minutes | Online self-paced training

Disaster Case Management Part 1: Introduction to Disaster Case Management is a beginner-level course designed to teach participants the basics of disaster case management (DCM), its role in disaster recovery, and the benefits a disaster case manager can offer to communities impacted by disaster.

Disaster Case Management Part 2: Core Considerations

Disaster Case Management Part 2: Core Considerations is a beginner-level course designed to teach participants the basics of disaster case management (DCM), its role in disaster recovery, and the benefits a disaster case manager can offer to communities impacted by disaster.

Suggested prerequisites: Introduction to Disaster or Just in Time: Disaster Response, and Disaster Case Management Part 1: Introduction to Disaster Case Management



Introduction to Construction Management



Average of 60 minutes | Online self-paced training

Introduction to Construction Management is a beginner-level course designed to teach participants what construction management is, its role in disaster recovery and how the construction management process fits in with other long-term recovery activities.

SELF-PACED ONLINE TRAINING



Introduction to Disaster

Four modules with an average of 60 minutes each | Online self-paced training

Introduction to Disaster is a foundational four-module course designed to give active disaster response or recovery participants the foundational tools needed to help their community. It is for individuals new to disaster response and provides a basic understanding of the agencies and organizations they may encounter. It also explains the phases of disasters, the services that may need to be developed, and the role of the local, state, and national emergency management agencies and offices of emergency management during the disaster's phases. Finally, it will offer ways your social ministry organization, synod, or congregation can assist in natural and human-caused disasters. This course is self-paced, and the modules can be taken independently. Each module takes approximately an hour, bringing the entire training to roughly four hours.



Just In Time: Disaster Response



Average of 60 minutes | Online self-paced training

Just In Time: Disaster Response is a shortened version of *Introduction to Disaster*. It covers the same information, in less depth, and is designed for participants responding to an active disaster or recovery response. This course is self-paced, and can be taken in roughly an hour.

Preparedness for Nonprofit and Faith-Based Organizations

Average of 60 minutes | Online self-paced training

Preparedness for Nonprofit and Faith-Based Organizations is an entry-level course designed to teach participants how organizational preparedness is defined, what it entails, the six attributes of a prepared organization, and common challenges that organizations face in becoming prepared.

Psychological First Aid: An Overview

Average of 60 minutes | Online self-paced training

Psychological First Aid (PFA): An Overview will introduce the principles and core actions of PFA and describe ways to apply them in post-disaster scenarios and with different survivor needs. PFA, the practice of recognizing and responding to people experiencing crisis-related stress, can be used to help yourself and others to cope in the face of stressful events.
