SUPPLY PASTORS COMPENSATION

Compensation to visiting pastors is the responsibility of the host congregation !Congregations should consider the following to be a guideline in compensating supply pastors:
Compensation to visiting pastors is the responsibility of the host congregation. The Southwest California Synod has a wealth of clergy to choose from when a congregation is in need of a

- **supply pastor. Congregations should consider the following to be a guideline in compensating supply pastors:**
- **One Service of Worship \$290**
- **Two Services of Worship (same day) \$355**
- **Preparing for and Teaching Bible Class/Adult Forum \$140**
- **In addition, mileage should be reimbursed at the same rate as documented under REIMBURSEMENT OF PROFESSIONAL EXPENSES, (beginning on page 3).**
- **Example: A supply pastor serving at a Saturday evening worship service and two Sunday morning worship services should receive \$290 + \$355 = \$645 + travel**
- **Supply pastors should be paid on the day they provide the service.**
