# I. WHO CAN ENTER

This giveaway is open to **U.S.** military veterans, active-duty service members, and current or former first responders who live within Aggieland Roofing's service area. Participants must be at least 18 years old and must own and live in the home being entered. The home must be a single-family residence and used as the participant's primary home.

Rental properties, vacation homes, multi-family properties, and commercial buildings are not eligible.

Military service must be honorable and completed in one of the following branches: Army, Navy, Air Force, Marine Corps, Coast Guard, or Space Force. First responders include firefighters, law enforcement officers, paramedics, and EMTs.

Employees of Aggieland Roofing & CR Systems and members of their immediate households are not eligible to participate.

#### II. HOW TO ENTER

To enter, complete the official giveaway form online at www.RooferGirl.com/roofgiveaway, at any Aggieland Roofing event, or in person at our office in Bryan. Only one entry per household is allowed.

If selected as a finalist, participants will be asked to provide documentation confirming eligibility, such as proof of military service or first responder employment. Incomplete or duplicate entries may be disqualified.

### III. ENTRY TIMELINE

Entries will be accepted beginning January 15, 2026 and must be received by March 1, 2026 at 11:59 PM (CT). Entries submitted outside of this timeframe will not be considered.

Finalists will be reviewed in March 2026, and the selected recipient will be notified on or around March 15, 2026.

### IV. WHAT THE WINNER RECEIVES

The selected recipient will receive a residential roof replacement for their primary home, including labor and standard asphalt shingle materials, with an approximate value of up to \$20,000.

Before installation, Aggieland Roofing will conduct a roof inspection to confirm eligibility and determine the appropriate scope of work. The prize includes standard asphalt shingles and limited decking replacement (up to 128 square feet).

The prize does not include specialty roofing systems, major structural repairs, interior work, or repairs unrelated to the roof. If the roof condition or design would cause the project to exceed the maximum prize value or create safety concerns, an alternate recipient may be selected.

The prize is not transferable and cannot be exchanged for cash.

### V. HOW THE RECIPIENT IS SELECTED

After the entry period closes, a local selection panel will review eligible entries. Submissions may be evaluated based on roof condition, financial need, structural considerations, and service background.

A group of finalists will be contacted and asked to confirm eligibility, provide proof of home ownership and insurance, and allow a complimentary roof inspection. One final recipient will be selected following this review process

#### VI. NOTIFICATION AND REQUIREMENTS

The winner is solely responsible for any applicable federal, state, and local taxes associated with the prize. If the prize value exceeds \$600, Sponsor will issue a 1099-MISC tax form to the winner. The winner may wish to consult a tax professional regarding tax implications of entering this Giveaway.

Finalists and the selected recipient will be contacted using the phone number or email provided at entry. Participants must respond within the requested timeframes and provide required documentation to remain eligible.

The selected recipient must maintain active homeowner's insurance throughout the installation process and coordinate with Aggieland Roofing to schedule installation.
