Fee Schedule Permits and Services

Construction / Operational Fee Schedule

Building Construction and Fire Safety Permit. This fee is for processing building plans submitted for code approval and shall be paid at the time of the submission of the plans.

Operating Without a Permit.

The fire code official may impose a double permit fee(s) (**100% penalty fee**) when the fire official finds that a condition, activity, or occupancy requiring a construction or operational permit(s) exist and **no approved permit** has been issued by the fire code official.

- Maximum penalty \$500.00/day for constructing without an approved construction permit.
- Maximum penalty \$500.00/day for operating without a required operational permit.

The base fee for all submitted plans and specifications is \$25.00. Projects with a valuation over \$1,000.00 will use the following table: TABLE INSERT

\$1000.00 and less	\$25.00, plus \$71.00 for each inspection (s)
\$1,000.00 up to \$50,000.00	\$25.00 for the first \$1000.00 plus \$5.00 for each additional thousand or fraction thereof, to and including \$50,000.00; plus \$71.00 for each inspection (s)
\$50,001.00 up to \$100,000.00	\$265.00 for the first \$50,001.00 plus \$4.00 for each additional thousand or fraction thereof, to and including \$100,000.00; ** One (1) complimentary inspection included
\$100,001.00 up to \$500,000.00	\$465.00 for the first \$100,001.00 plus \$3.00 for each additional thousand or fraction thereof, to and including \$500,000.00; ** Two (2) complimentary inspections included
\$500,001.00 and up	\$1,665.00 for the first \$500,001.00 plus \$2.00 for each additional thousand or fraction thereof. ** Three (3) complimentary inspections included

Burn Permits

- ❖ **Agricultural Permit (NO charge)** Must fill out application and provide a copy of valid Texas Agricultural or Timber Registration Card.
- ❖ **Bond Fire \$25.00** Must fill out application and submit ten days prior to event.
- ❖ **Residential Burn Permit \$15.00** Must fill out questionnaire to include map of expected burn site

Cancellations

- ❖ All Cancellations will require a 24-hr. notice.
Failure to cancel with a 24-hr. notice will result in additional fees

Care License inspections

Applicant must submit a licensed plumber's carbon monoxide inspection.

- ❖ **\$71.00/hr.** (fee does not apply to Head Starts) for initial inspection fee & re-inspection(s) fee.
- ❖ State licensed facilities that require annual fire inspections for operational permits.
 - Daycares
 - Head Start Centers **\$185.00** for Initial Inspection & Re-Inspection
 - Nursing or care centers
 - Hospitals
 - Institutional restrained
 - Licensed in home facilities
 - Foster homes or adoption centers

Display of Fireworks and/or Pyrotechnic Special Effects

- ❖ **\$250.00** per event
- ❖ Site plan approval and permit for public, proximate audience, indoor or outdoor display
- ❖ Copy of State Permit required for onsite inspection
- ❖ Provide copy of Pyrotechnic License
- ❖ Prove copy of liability Insurance

Event Permit

- ❖ **\$300.00** per event
- ❖ Must include detailed plot plan of event
- ❖ Temporary Tents more than 200 square feet require additional permit
- ❖ Prove copy of liability insurance.

Event Fire Watch for systems out of service.

- ❖ **\$100.00/hr.** per Fire Marshal (minimum of two Fire Marshal's for 4/hrs.)

Expedited Service for Inspections and Plan Review

- ❖ **\$144.00/hr.**
- ❖ **\$100.00/hr.** (OT rate) Fire inspection-other than regular duty hours

Flammable or Combustible Liquid Tanks Permit

- ❖ **\$142.00** for each system for plan review and permit

Fire Alarm System Permits (PLAN REVIEW & PERMIT)

- ❖ **\$150.00** for systems with up to 200 initiating and/or signaling devices.
- ❖ **\$0.50** for each additional initiating and / or signaling device
- ❖ **\$1,500.00** (Maximum fee) * ***does not include final or testing***
- ❖ **\$71.00/hour** for the final/partial inspection acceptance test

Fire Hydrant/ Standpipe/ Water Supply/ Water Tank (UG or AG) Permit.

\$100.00 per system. The fee covers the plan review and permit process.

****The above fee ***does not*** include the 2-hour-static test (AG/UG) or final. ****

- ❖ **71.00/hr.** for the final/partial inspection/acceptance test (shall be pre-paid)
- ❖ **\$142.00** for any 2-hour hydro-static test or partial test (shall be pre-paid)

Fire Protection System permits. (Sprinkler, range hoods; spray booths, special systems; FM200; etc...)

- ❖ Fixed pipe suppression system permit:
 - **\$71.00** for plan review and permit. Plus
 - **\$71.00** for final/partial inspection/acceptance test
- ❖ Fire sprinkler system permit: (PLAN REVIEW & PERMIT)
 - **\$150.00** for systems with up to 200 fire sprinkler heads
 - **\$0.50** for each additional head
 - **\$1,500.00** (Maximum fee) * ***does not include final or testing***
 - **\$142.00** for any two (2) hour hydro-static test or partial test
 - **\$71.00** for final inspection / acceptance test

****The above fee ***does not*** include the 2-hour-static test (AG/UG) or final. ****

- ❖ **71.00/hr.** for the final/partial inspection/acceptance test (shall be pre-paid).
- ❖ **\$142.00** for any 2-hour hydro-static test or partial test (shall be pre-paid).

Fireworks (sale) and/or Pyrotechnic Special Effects

- ❖ **\$100.00** for the first stand
- ❖ **\$25.00** for each additional stand at the same location
- ❖ Copy TDI State Fire Marshal Permit Number, Tax ID Number & Insurance required for onsite inspection.
- ❖ Permit is good for 365 days (1 year) from date of purchase
- ❖ **\$250.00** for each storage, handling, or use of fireworks/pyrotechnical special effects.
- ❖ **\$250.00** for store only

Modification/Alteration Permit

Only applies to an existing Fire Alarm/ Fire Sprinkler Permit.

- ❖ **\$71.00** for plan review, permit and final.
Includes: Existing sprinkler systems (up to twenty sprinkler heads)
Existing alarm systems (up to ten initiating/signaling devices)

Plan Review/Consultation

- ❖ **\$75.00 per every \$500,000.00 of the total cost of the project** for the preliminary review of plans, which have not been submitted for approval for which no permit has been issued.

Re-inspection/Retest

- ❖ **\$71.00/hr.** for each re-inspection/re-test

This fee **shall be paid prior** to any additional subsequent inspections are made

- ❖ **\$71.00** Permit renewal

Schools Annual Fire/Safety Inspection

- ❖ From Pre-School up to the 12th grade
- ❖ **No Charge** for first inspection **\$185.00** per re-inspection

Smoke Control System Installation Permit

- ❖ **\$71.00** for each system

Standpipe/Water Supply Permit

- ❖ **\$100.00** per system when not installed in conjunction with new building construction
