# VI. NEW BUSINESS.

- A. Special Rules clarifications for baseball
  - a. No new inning shall start after 8:00pm EST. The first live pitch of the inning must be thrown by 8:00pm EST.
  - Penalties will be enforced for not adhering to the CSL rules on Pitch Counts.
     Note: Each team is responsible for their own pitch count, however, both teams should be tracking all pitchers pitch counts.
    - i. 1st offense: the offending team will forfeit the game
    - ii. 2nd offense: the offending team will forfeit and a \$50 fine will be imposed

- iii. 3rd offense: the offending team will forfeit and a \$100 fine will be imposed. In addition, league disciplinary actions will be discussed for the repeat offending head coach.
- c. Rule Clarification: A pitcher that is removed from the mound mid-inning <u>and</u> <u>placed directly into a defensive position</u> (not the bench) <u>may come back in to</u> <u>pitch</u> later in the game as long as they have not exceeded their pitch counts.
- B. Coaching and volunteer background checks. A discussion was held to ensure that all communities are taking the appropriate actions and clearing their coach and field volunteers to ensure player safely throughout the league. Resources will be uploaded to the CSL website for background checks.
- C. Umpires for baseball. If a community is using volunteer umpires, there are free resources at USA Baseball to obtain a certification.
- D. Voting for 2 open Members at Large will take place at our next meeting.
  - a. Member at Large #1: Tim Ebersole, Hamilton Heights, was nominated by JP Burnham and Ben Frantz 2nd the motion.
  - b. Member at Large #2: will be vacated. Please ask your communities for volunteers.
