What information we collect and why ?

We use this information to answer inquiries, create proposals, deliver marketing campaigns, issue invoices, improve our content, and keep the site secure.

How we share information

We don’t sell personal data. We disclose it only to trusted service providers—web-hosting companies, email and SMS platforms, payment processors, analytics partners, and professional advisers—who need the information to perform work on our behalf and who agree to keep it confidential. If the law requires us to share data with courts or regulators, we comply only to the extent necessary.

Cookie, pixels and similar tech

Like most modern sites, we set cookies and use pixels from platforms such as Google Analytics and Meta to remember your preferences, measure site performance, and show you relevant ads. You can delete or block cookies in your browser settings, but some site features may not function as intended.
