## Disbursements

Disbursements are items arranged for you and paid to third parties on your behalf by the funeral home. You are expected to pay for these items at the time the contract is billed. We may ask for an advance payment where the disbursements are expected to be higher than customary. The following examples are often identified as disbursements.

- Coroner's fee – this is a fee charged by the coroner for issuing a certificate that allows cremation to take place. The fee is set by the Chief Coroner for Ontario.
- Clergy honorarium – this is an amount paid to the clergy for their services. In some cases the amount is set by the clergy, in others it is an amount determined by you.
- Organist and cantor fees – these are payments made to organists and cantors for their musical services according to an agreed tariff.
- Crematorium fee – this is the charge made by the crematorium for the services of its staff and the use of its facilities.
- Newspaper or radio notices – these are charges for death notices placed in newspapers or radio or other media outlets.
- Municipal death registration fee – this is a fee charged by the local municipality to register the death. The fee is set by the municipality and may vary.
- Bereavement Authority of Ontario Consumer Protection Fee - this fee is charged by the Bereavement Authority of Ontario (BAO) for providing information about consumer options in bereavement services, and to regulate the profession making sure the law is consistently followed.

## Payment, financing and funding

**Payment:** The purchaser agrees to pay the balance of account due and any additional services and goods, which the purchaser may order subsequent to the making of this contract, as outlined in the following credit policy of Kopriva Taylor Funeral Home Inc. All accounts are due upon receipt.

- **Credit Information Required:** The Provider is extending credit to the purchaser of this contract and therefore the credit information, which will be requested, includes the following; Valid Driver's Licence, Valid Credit Card and Social Insurance Number. This same information will be collected for the co-purchaser. Copies of these documents will be required for our file.
- **Balance of Account due:** After the funeral, a formal statement of account will be sent to you with all final charges, including any adjustments for cash disbursements. Your deposit will be reflected on this statement, and the balance of your account will be due upon receipt.
- **Payments** acceptable include Cash, Debit Card, Cheque, Visa, and MasterCard.

- **Delinquent Accounts:** The Provider reserves the right to submit a delinquent account to a collection agency if there is no satisfactory resolve to the payment of account. Accounts will be submitted for collections after 60 days. We take every effort to help the families we serve, and financial arrangements can be discussed with your funeral director.
- **Failure to pay:** if the purchaser fails to make payments required under this contract to the Kopriva Taylor Community Funeral Home, all expenses of collection, (currently 22% of the total contract plus HST will apply, subject to change without notice), the purchaser will pay including court costs and reasonable lawyer fees incurred to The Provider in pursuing the claim against the purchaser.
- **Returned cheques:** If a cheque is returned NSF, then an administrative fee of \$45.00 will apply, along with actual bank charges as charged by The Provider's financial institution.

Unless otherwise specified, payment is due upon receipt of the final account.

## Funding of Prearranged Prepaid Funerals

For your convenience, we offer two funding options when prepaying services or supplies. When prepaying, you pay for the services and supplies today and the money will be used to pay for the services and supplies when they are provided at the time of death.

**Insured Group Annuity:** You may purchase an Insured Group Annuity contract which will be held at a financial institution where it will accrue interest until the services and supplies are provided.

**Trust:** You may pay into a trust account which be held at a financial institution, where it will accrue interest until the services and supplies are provided.
