## **Agenda**

- John called the meeting to order and gave an annual report for the past year. He
  recounted the various expenses we'd had in the past year. He noted that we were over
  budget for the year and mentioned some things in the neighborhood that we hoped to
  address in the coming year but that the board had voted against raising dues at this
  time.
- Treasurer's Report: We paid our yearly insurance premium. Our landscaping and pool
  maintenance costs are normal for this time of year. We did have over \$5000 in water
  expenses due to a slow leak. Mike expressed that he was against raising dues while we
  have such substantial cash reserves, however, we would likely revisit the subject and
  may have to increase dues in the coming year.
- John recognized Sophie Martin, our city council representative. Sophie shared that the new subdivision by the railroad tracks will have about 200 homes. The city is working with Shelby County on potentially widening CR 11 a little down from Weatherly.
- Kelly took the opportunity to let everyone know that the clubhouse was fully paid off this
  year. She also mentioned various improvements that we've made and are planning to
  make. She then addressed some questions that were submitted by residents prior to the

meeting.

After opening the meeting to questions from the residents in attendance, many expressed concerns about the remaining Bradford pear trees and the desire to have them removed.

• The board entered into an executive session:

Mike Ream was accepted as the new representative of the Warwick sector. John nominated Kelly for board president. She was elected unanimously. Kelly nominated Dan for vice president. He was elected unanimously. Kelly nominated Mike for treasurer. He was elected unanimously. Kelly nominated Steve for secretary. He was elected unanimously.
