RELEVANT EXPERIENCE

Moreton Bay Indoor Sports Centre – The MBISC is slated to be one the sporting venues for the 2032 Olympics and Paralympics in Brisbane. Renee and the WPG team carried out a Social Impact Evaluation for the proposed facility with the baseline study extending out to surrounding community to assess its continued use post-Olympics. This project has had a highly successful outcome, with the Sports Venue Review recommending the development go ahead and allocating a GREEN rating – the only Olympic venue to date to have received this.

Nebo Showgrounds Master Plan – The Wall Planning & Environmental Consulting team, in partnership with Isaac Regional Council (IRC), are developing a master plan that will support dynamic economic and social opportunities.
