Explanation of Charges

Professional & Staff Services

Co-ordinating activities, rites, ceremonies \$ 1095.00

- Professional consultation with licensed personnel, including, but not limited to, expert advice on options to meet your needs. Co-ordination of activities, rites, and ceremonies, before, during and after they have been provided, including services and supplies provided by us, as well as those provided by third party suppliers.
- In the case of Transfer Service only with no ceremony this charge is reduced to: \$ 695.00

Documentation – permits, forms, etc. \$ 300.00

- Completion and filing of documents necessary to carry out the services and supplies requested, including, but not limited to, documentation necessary to ship the body out of the country, CPP Benefits. Provision of 6 Proofs of Death issued by the Funeral Home (proofs of death are usually accepted for estate settlement purposes). Additional copies of “Proof of Death” additional charge applies \$20.00 each.
- In the case of Transfer Service only with no ceremony this charge is reduced to: This includes 1 Proof of Death (Additional copies of “Proof of Death” additional charge applies \$20.00 each). (Family will take care of their own CPP Benefits). \$ 300.00

Transport remains – (within 40 km; additional fees apply beyond 40 km,) \$ 425.00

- Transport of the remains from place to place, example the hospital to business, a charge applies for all transportation requests

Basic preparation of remains (requires Facilities for reparation/embalming/shelter) \$ 275.00

- The preparation of the body for placement into the casket, may include topical disinfection, dressing if required and the setting of facial features for identification or viewing without embalming.

Embalming of remains (requires Facilities for preparation/embalming/sheltering) \$ 495.00

- Embalming is the process of replacing blood and bodily fluids with chemical preservatives. It is a process of sanitation, restoration, and temporary preservation. Embalming is not legally required but may be recommended to preserve the body between the time of death and the visitation, disposition of the deceased. Our professional funeral directors will make a recommendation based on the condition of the body and expected service needs.
- This charge is in addition to Basic Preparation of remains.

Refundable Deposit for Cremated Remains (If Charged) \$ 350

- When human cremated remains are to be stored, a refundable deposit will be required to be paid. If the cremated remains are not claimed within one year of the cremation, the deposit may be used to inter the cremated remains in common ground. If remains are claimed before one year, the deposit will be refunded

Cremated Remains Storage Fee \$ 25
• When human cremated remains are stored with the funeral home. A storage fee of \$25.00 per month will be charged Per month

Removal of pacemaker or implant \$ 150

- Removal of a pacemaker or implant will be carried out by a licensed professional.

Professional restorative procedures \$ 150 per hour
• In some circumstances, additional restorative efforts beyond those captured in the standard embalming procedure are necessary to enhance the appearance of the deceased. In such cases, the funeral director will discuss the available options and their cost. Professional restorative procedures will be charged per hour.

Scattering of cremated remains \$ 250+

- We will scatter cremated remains in accordance with Ontario and municipal laws and by-laws on land. Fees for scattering in addition to this charge and will be discussed upon request. Cemetery fees are extra payable to the cemetery

Out of Town Assisted Services/Burials

- From time to time an out-of-town funeral home will request our funeral home to assist with a burial or shipped in cremated remains. Costs vary on requirements. See Pricelist

Disbursements

Disbursements are items arranged for on your behalf. You are expected to pay for these items at the time the contract is entered into. The following items that are identified as disbursements and are charged At Cost.

Coroner's fee – this is a fee charged by the coroner for issuing a certificate that allows cremation to take place. The fee is set by the Chief Coroner for Ontario.

Clergy honorarium – this is an amount paid to the clergy for their services. In most cases the amount is set by the clergy.

Newspaper notices – these are charges for death notices placed in newspapers or other media outlets.

Municipal death registration fee – this is a fee charged by the local municipality to register the death. The fee is set by the municipality and may vary.

Bereavement Authority of Ontario Protection Fee- A fee set and required by the BAO, that is levied to consumers as a regulated cost \$30.00 (a disbursement paid by the consumer through the Funeral Home to the BOA) for the BOA to regulate the province's bereavement sector and to provide information as well as public and consumer protection regarding consumer options and rights for bereavement services. The fee is cumulative and paid by the consumer per each bereavement sector service.

Luncheon/Catering – This is charged at cost for catering provided by a local caterer or service club.

Hall Rental Fee – This fee is for the rental of service club halls for the catering of luncheons.

Caretaker Fee – This fee is charged if there is a caretaker fee for local churches and or service clubs.

Organist Fee– This fee is charged if the client requires an organist to play for the service.

Piper Fee– This fee is charged if the client requires a piper to play for the service.

Winter Vault – This fee is charged if the deceased cannot be buried due to cemetery seasonal closures (winter). This one-time charge is for the storage of deceased persons in a local storage facility.

Payment Unless otherwise specified, payment is due upon signing the contract and no interest will be charge if paid within 30 days. Payment may be made by cash, cheque, debit, and most major credit card. Beyond the allotted time, interest will be charged from the date of the contract at a rate of 2% per month which is equivalent to 24% per annum (APR). If you are prepaying for services or supplies, pre-authorized debit is also available. Additional information about the funding, payment and financing options is available upon request.

Financing For prepaying of services Only:

Our payment plans give you the option of making payments over time. We offer a competitive financing program, administration fees and interest rates.

Funding For your convenience, we offer two funding options **when prepaying services or supplies**. When prepaying, you pay for the services and supplies today, and the money will be used to pay for the services and supplies when they are delivered at the time of death.

Trust: You may pay the money directly to us and we will place it in trust, where it will accrue interest until the contract is fulfilled (when the services and supplies are delivered) or the contract is cancelled.

Insurance: You may purchase an insurance contract where the proceeds of the insurance contract will be used to pay for the services or supplies at the time they are delivered, or the contract is cancelled.
