PROFESSIONAL & STAFF SERVICES

Basic professional fees (requires Basic Facility Charge) \$ 430.00

- Professional consultation with licensed personnel, which may include but is not limited to, expert advice on options to meet your needs, including essential services relating to disposition, drafting notices, planning/scheduling of services, advising regarding possible government benefits. A Basic professional fee is payable whenever we provide services to you.

Co-ordinating rites and ceremonies \$ 375.00

- Co-ordination of all rites and ceremonies, before, during and after they have been provided, including services and supplies provided by us, as well as those provided by third party suppliers, such as flowers and death notices.

Documentation – permits, forms, etc. \$ 385.00

- Completion and filing of all documents necessary to carry out the services and supplies requested, including, but not limited to, death registration, burial permit, coroner's certificate for cremation, documentation necessary to ship the body out of the country. As part of this service, we will provide you with 10 proof of death certificates; such certificates are usually accepted for most estate settlement purposes, but sometimes a provincial Death Certificate will be necessary and is available from the Office of the Registrar General.

Transport remains (required each time the human remains are transported, price per staff person) \$ 125.00

- Transportation of the remains from one place to another, for example the hospital to our premises, or from our premises to the cemetery or crematorium using a transfer vehicle, for distances not exceeding 50 km.
- Additional staff service charge per person will apply for transfer of the remains if required due to an institutional policy or the safety of the employees of the funeral home.

Embalming of remains (requires Facilities for preparation/embalming/shelter) \$ 450.00

- Embalming is the process of replacing blood and bodily fluids with chemical preservatives. It is a process of sanitation, restoration, and temporary preservation. Embalming is not legally required but may be recommended to preserve the body between the time of death and the visitation or disposition of the deceased. Our professional funeral directors will make a recommendation based on the condition of the body and expected service needs.

If the cremated remains are not claimed by the Purchaser within 1 year, the Funeral Home may inter the cremated remains in a cemetery, including in a common lot for which the cemetery or the funeral home is the interment rights holder, and the Funeral Home may retain the deposit referred to in this section. If the cremated remains are claimed before they are interred, the Funeral Home will promptly refund any deposit paid. The Purchaser shall pay the monthly cremation storage fees on the first day of each month following the date the Funeral Home takes possession of the cremated remains until the date the Purchaser picks up the cremated remains

Disbursements

Disbursements are items arranged for and possibly paid for on your behalf by us. You are expected to pay for these items at the time the contract is entered into. The following are some items that are often identified as disbursements.

Bereavement Authority of Ontario Consumer Protection Fee - This fee is charged by the Bereavement Authority of Ontario (BAO) in order to provide its services of Information on your options in bereavement services and to regulate the profession making sure the law is consistently followed. \$30.00 (HST Exempt)

Coroner's fee – this is a fee charged by the coroner for issuing a certificate that allows cremation to take place. The fee is set by the Chief Coroner for Ontario. \$75.00 (HST Exempt)

Municipal Death Registration– this is a fee charged by the local municipality to register the death. The fee is set by the municipality and may vary. Town of Georgina \$25.00 (HST Exempt)

Clergy Honorarium – this is an amount paid to the clergy for their services. In some cases, the amount is set by the clergy, in others it is an amount to be determined by you.

Organist/Pianist Honorarium - this is an amount paid to the organist/pianist for their services. In some cases, the amount is set, in others it is an amount to be determined by you

Piper Honorarium - this is an amount paid to the piper for their services. In some cases the amount is set; in others it is an amount to be determined by you

Newspaper or radio notices – these are charges for death notices placed in newspapers or radio or other media outlets. The amount is determined by the length of the notice and if a photo or logo is included.

Catering – The provision of food available from a number of quality suppliers. The amount is set by the supplier based upon the quantity of food ordered.

Hairdresser - Arranging for a Professional Hair Dresser to attend to the trimming and styling of the deceased hair price is set by the stylist and will vary with the requests of the purchaser.

Monument Inscriptions – We are pleased to represent Shelburne Memorials Limited to inscribe your existing monument. The cost is set by Shelburne Memorials Limited by the number of characters to be inscribed.

Transport of Cremated Remains – This is the cost a third party will charge to transport the cremated remains.

Specialized Scattering of Cremated Remains - Fees for scattering cremated remains from a plane or boat will be those charged by the owner/operator of the vessel.

Cremation Fee- Fee set by the crematorium for the cremation of the deceased, Prices vary depending on crematorium used.
