**Code Enforcement:** Larry Minifield, Code Enforcement, completed 33 inspections and violations with seven being complaint-driven. Total cases resolved were 13 and nine being voluntary compliant. Fines issued totaling \$3,050.00. Code Enforcement 87 ongoing cases with action plans in place for resolution. Flock cameras should be installed by December.
