WHEREAS the Jefferson Township Trustees want to ensure that all Public Property and Operations are insured, and

WHEREAS the Jefferson Township Trustees have had staff review the Policy and Update inventories that are covered by the Insurance Policies;

WHEREAS the Jefferson Township Trustees authorize the Lump Sum Payment of \$96,809.00 to be sent by the Fiscal Officer in a timely manner; and

WHEREAS the Jefferson Township Trustees also request that the Fiscal Officer allocate costs based on the attachment, "Exhibit A," to each Department; and

WHEREAS the Jefferson Township Trustees recognize that the Bonding of Elected Officials is a separate policy from the Property/Casualty Policy that is being renewed, and there are invoices issued separately for each type of policy;

WHEREAS the Jefferson Township Trustees recognize the changes of coverage through the 2025-2026 period and may require a new premium to be paid or a refund to be received by the Township.

NOW, THEREFORE, BE IT RESOLVED, the Jefferson Township Trustee does hereby renew the Jefferson Township Property Casualty Insurance Policy for 2025/2026 with the Ohio Township Association Risk Management Authority in the amount of \$96,809.00.

WHEREAS, The Board of Trustees of Jefferson Township, Montgomery County, have determined that it is necessary to levy an additional tax outside of the ten millage limitation for Jefferson Township, Montgomery County, for the purpose of current expenses as authorized by Section 5705.19 (A) of the Ohio Revised Code; and

WHEREAS, The Board of Trustees of Jefferson Township proposes that said tax be a levy tax as authorized by section 5705.19 (A) of the Ohio Revised Code; and

WHEREAS, Section 5705.03 (B) of the Ohio Revised Code requires the Township to certify to the county Auditor a resolution requesting the County Auditor certify to the Township the total current tax valuation of the Jefferson Township, Montgomery County.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees, of Jefferson Township, Montgomery County, Ohio that in accordance with Section 5705.03 (B) of the Ohio Revised Code, the Board of Trustees of Jefferson Township hereby request the Auditor of Montgomery County, Ohio to certify the total current tax valuation of the Jefferson Township and the dollar amount of revenue that will be generated by an additional _____ mills **current expenses levy** for a period of _____ (___) years to be placed upon the ballot at the General Election to be held on November 4, 2025: Such levy shall be placed upon the 2025 tax list and duplicate for first collection in calendar year 2026.

WHEREAS, The Board of Trustees of Jefferson Township, Montgomery County, have determined that it is necessary for an additional levy of a tax outside of ten millage limitation for Jefferson Township, Montgomery County, for general construction.....See Section 5705.19 (G) as authorized by Section 5705.19 (G) of the Ohio Revised Code; and

WHEREAS, The Board of Trustees of Jefferson Township proposes that said tax be a levy tax as authorized by section 5705.19 (G) of the Ohio Revised Code; and

WHEREAS, Section 5705.03 (B) of the Ohio Revised Code requires the Township to certify to the county Auditor a resolution requesting the County Auditor certify to the Township the total current tax valuation for Jefferson Township, Montgomery County.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees, of Jefferson Township, Montgomery County, Ohio that in accordance with Section 5705.03 (B) of the Ohio Revised Code, the Board of Trustees of Jefferson Township hereby request the Auditor of Montgomery County, Ohio to certify the total current tax valuation for Jefferson Township and the dollar amount of revenue that will be generated by an additional ______ mills streets, **roads and bridges levy** for a period of _____ (____) years to be placed upon the ballot at the General Election to be held on November 4, 2025: Such levy shall be placed upon the 2025 tax list and duplicate for first collection in calendar year 2026.
