## 7. Department Reports

Road Department: Kenneth Smith, Road Supervisor, stated that the road department had installed the culvert pipe on Germantown Liberty Road, rip rap rocks are still needed on the ends to make sure it doesn't wash away. Asphalting of the culvert pipe replacements will begin soon. Cutbacks and being done when the tractor is up and running. Lot cuts stemming from violations are Germantown Pike, Derby Road, Radcliffe Heights. Other properties maintained by the road department include Richardson Park, Lower Miami Valley Cemetery, and Blairwood Park. Maintenance updates, Ford tractor had the rear mower repaired, Dump truck 002 will be completed by the end of the week, and 03 mower had the PTO clutch and belt replaced.

Code Enforcement: Larry Minifield, Code Enforcement, completed 32 inspections and violations with two being complaint-driven. Total cases resolved were twenty-five and twenty-one being voluntary compliant. Fines issued totaling \$1,450.00. Code Enforcement has four nuisance abatement cases with one being in compliance and another promising to be compliant soon. Junk vehicles, trailers, and abandoned vehicles are becoming increasingly less of a hindrance while RV's continue to be an ongoing issue.
