## A RESOLUTION TO DECLARE THE PROPERTIES LISTED AS NUISANCES ON THE ATTACHED LIST AND AUTHORIZE THE REMOVAL, REPAIR OR SECURANCE OF SAID STRUCTURES

The Board of Trustees of Jefferson Township, Montgomery County, Ohio met in special session on the 21<sup>st</sup> day of September, 2021 at 7:00 pm. at the Township Offices with the following members present:

Trustee McGurre moved for the adoption of the resolution.

**WHEREAS**, the Jefferson Township Board of Trustees has received numerous complaints of abandoned, structurally defective and unsecured structures in the Township;

WHEREAS, the Jefferson Township Board of Trustees finds abandoned, structurally defective and unsecured structures within Jefferson Township are unsafe and unsightly, and are detrimental to property values and are injurious to the health, safety, welfare, and morals of the community; and

**WHEREAS**, the Jefferson Township Board of Trustees has determined that it is the policy of the township to secure, repair or remove abandoned, structurally defective and unsecured structures found in the unincorporated areas of the Township pursuant to Ohio Revised Code Section 505.86; and

**WHEREAS**, Ohio Revised Code 505.86(B) specifically authorizes the Jefferson Township Board of Trustees to provide for the removal, repair, or securance of buildings or other structures in the township that have been declared insecure, unsafe, or structurally defective by any fire department under contract with the township; and

WHEREAS, Ohio Revised Code 505.86(B) authorizes the Chief of the Jefferson Township Fire Department to declare structures unsafe with unsafe conditions; and

WHEREAS, Jefferson Township Fire Chief Doug Wright has inspected and found the following structures (see attached list) to be unsafe and structurally defective; and

WHEREAS, the Landbank 2.0 Demolition Program permitted three additional properties to be added to the list;

**WHEREAS** the Board of Trustees hereby determines that it is necessary to adopt a resolution pursuant to Ohio Revised Code Sections 505.86 to authorize the removal, repair or securing of these structures within the unincorporated area of Jefferson Township, to protect property values, and preserve the health, safety, welfare, and morals of the community.

**NOW THEREFORE, BE IT RESOLVED**, by the Board of Trustees of Jefferson Township, Montgomery County, Ohio, declare the properties listed as nuisances on the attached list and authorize the removal, repair or securing of said structures. (Attachment)
