

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MOU) is entered into on March 30, 2026 by and between the Jefferson Township Board of Trustees and the Montgomery County-Agricultural Society.

This agreement is made with reference to the following facts and objectives:

Jefferson Township maintains and operates a fire protection organization in Jefferson Township.

The Montgomery County Agricultural Society operates the annual Montgomery County Fair in Jefferson Township.

The Montgomery County Agricultural Society is in need of fire protection and emergency medical services during the annual Montgomery County Fair.

The parties mutually agree as follows:

1. The Montgomery County Agricultural Society agrees to compensate Jefferson Township Board of Trustees, in the amount of \$3,850.00 annually, to provide fire and EMS protection for each year of 2026, 2027, 2028, 2029, and 2030. This amount is based on a seven (7) day fair and shall be prorated should the annual fair dates be greater or less each year.
2. The Jefferson Township Board of Trustees agrees to provide Fire and EMS services to the Montgomery County Agricultural Society for the 2026 Montgomery County Fair from July 14 – 19, 2026. The dates for the remaining four (4) years of this MOU shall be determined in the future.
3. Food vouchers (valued at \$5.00/each) will be issued to the Fire Chief prior to the Fair. The Chief will distribute them during the week of the fair to the workers. The quantity needed will be at the Chief's discretion.

IN WITNESS WHEREOF, the Jefferson Township Board of Trustees and the Montgomery County Agricultural Society have executed this Memorandum of Understanding as of the date first written above.
