**THE JEFFERSON TOWNSHIP BOARD OF TRUSTEES AUTHORIZES THE PURCHASE OF A MINI AMBULANCE FROM CENTURY EQUIPMENT FOR THE JEFFERSON TOWNSHIP FIRE DEPARTMENT.**

The Board of Trustees of Jefferson Township, Montgomery County, Ohio, met in a regular meeting on May 5, 2026, at 6:00 pm at the Township Offices located at 1 Business Park Dr., Dayton, Ohio, with the following members present:

**WHEREAS**, <sup>Absent</sup> Jefferson Township Fire Department <sup>Yes</sup> is committed to ensuring the safety and protection of its residents through the provision of a Mini Ambulance; and

**WHEREAS**, the acquisition of a mini ambulance will enhance the Fire Department's ability to respond to medical emergencies efficiently, improve response times, and better serve the residents of Jefferson Township at community events; and

**WHEREAS**, Jefferson Township Fire Department has reviewed a proposal from Century Equipment for the purchase of a mini ambulance, including all necessary equipment and upfitting, for use by the Jefferson Township Fire Department; and

**WHEREAS**, the total cost of the proposed equipment and services is Thirty-Five Thousand (\$35,000); and

**WHEREAS**, the Board of Trustees finds that the purchase of the mini ambulance is necessary for the continued effective operation of the Jefferson Township Fire Department and is in the best interest of public safety.

**WHEREAS**, the Township solicited and received all necessary bids in accordance with applicable requirements, and after evaluation, Century Equipment was selected as the vendor whose proposal most effectively meets the Township's needs and budgetary requirements.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF JEFFERSON TOWNSHIP, MONTGOMERY COUNTY, OHIO:**

**Section 1.** The Board of Trustees hereby approves the purchase of the mini ambulance, including all necessary equipment and upfitting, for use by the Jefferson Township Fire Department.

**Section 2.** That the total expenditure for the mini ambulance shall not exceed \$35,000.00, plus any applicable taxes or fees, for the purchase of the mini ambulance and services described in the proposal.

**Section 3.** The Township Administrator and Fiscal Officer are authorized to take all action necessary to process payment, coordinate deliver, and ensure implementation of the mini ambulance.

**Section 4.** Funds for this purchase shall be paid from the appropriate Township fund designated for fire department operations, capital improvements, or other authorized funding source.

**Section 5.** This Resolution shall take effect and be in force immediately upon its adoption
