Section 1. Approval of Compensation Adjustments

Section 3. The Fiscal Officer is authorized and directed to make all necessary payroll adjustments consistent with this Resolution.

Section 4. It is found and determined that all formal actions of this Board concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Board in compliance with all applicable legal requirements.

Section 5. This Resolution shall take effect and be in force from and after the earliest period allowed by law.

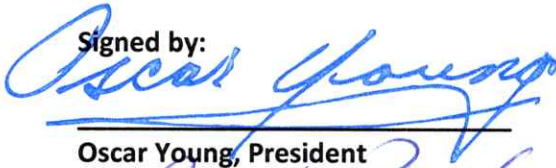
