WHEREAS, the Board of Trustees of Jefferson Township has adopted appropriations for Fiscal Year 2026; and

WHEREAS, the Township has funds available within the Road Capital Fund that are to be transferred to various Road Department funds to support authorized road-related expenditures and operations; and

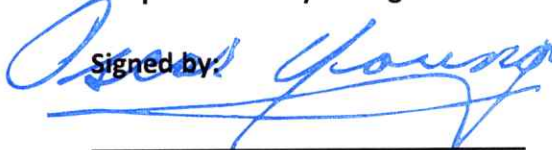

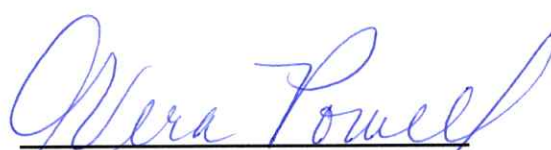

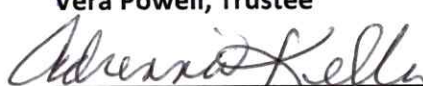
