WHEREAS, Resolution 26-012 was previously adopted by the Jefferson Township Board of Trustees authorizing increased hourly wages for part-time fire department employees based upon their qualifications, certifications, and assigned work schedules, in accordance with approved budgetary allocations; and

WHEREAS, certain part-time fire employees have transitioned to a shifted rotation schedule, thereby meeting the qualifications for an increased hourly wage rate pursuant to Resolution 26-012; and

WHEREAS, the Board of Trustees finds it necessary and appropriate to implement the applicable wage adjustments for those employees who meet the established qualifications under Resolution 26-012; and

WHEREAS, the employees identified below have met the applicable requirements and are eligible for the corresponding hourly wage rate as established by Resolution 26-012;

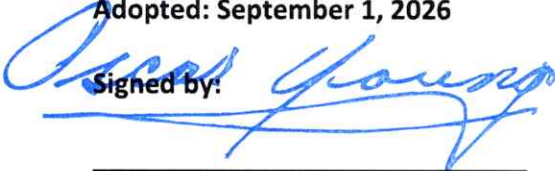

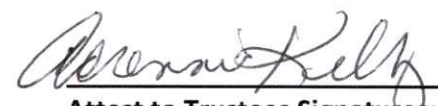
