**THE JEFFERSON TOWNSHIP BOARD OF TRUSTEES APPOINTS TIMOTHY LIGGINS TO THE JEFFERSON
TOWNSHIP BOARD OF ZONING APPEALS TO FILL THE UNEXPIRED TERM OF JOHN CASEBEER**

The Board of Trustees of Jefferson Township, Montgomery County, Ohio, met in a regular meeting on September 1, 2026, at 6:00 pm at the Township Offices located at 1 Business Park Dr., Dayton, Ohio, with the following members present:

WITNESSETH

WHEREAS, the Jefferson Township Board of Trustees is responsible for appointing qualified individuals to serve on the Jefferson Township Board of Zoning Appeals and for filling vacancies occurring on said Board; and

WHEREAS, on March 3, 2026, the Jefferson Township Board of Trustees adopted Resolution No. 26-030 appointing John Casebeer to the Jefferson Township Board of Zoning Appeals for a term commencing March 4, 2026, and expiring December 31, 2029; and

WHEREAS, the Jefferson Township Board of Trustees has taken action to remove John Casebeer from the Jefferson Township Board of Zoning Appeals, thereby creating a vacancy for the remainder of his unexpired term; and

WHEREAS, the Board of Trustees desires to promptly fill the vacancy to ensure the continued effective operation of the Jefferson Township Board of Zoning Appeals; and

WHEREAS, the Board of Trustees has determined that Timothy Liggins is qualified and willing to serve the residents of Jefferson Township as a member of the Board of Zoning Appeals;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Jefferson Township, Montgomery County, Ohio, that:

SECTION 1. Appointment

The Jefferson Township Board of Trustees hereby appoints Timothy Liggins to the Jefferson Township Board of Zoning Appeals to fill the vacancy created by the removal of John Casebeer.

SECTION 2. Term

Timothy Liggins shall serve for the remainder of John Casebeer's unexpired term, effective upon adoption of this Resolution and continuing through December 31, 2029, unless otherwise provided by law.

The Township Administrator and Zoning and Development Coordinator are authorized and directed to update the Township's official records and Board roster to reflect this appointment.

SECTION 5. Effective Date

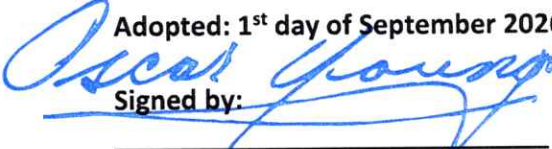

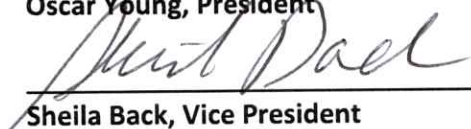

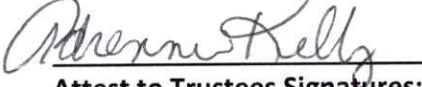
